

PRIVACY NOTICE

Protecting the privacy and security of your personal information is important to us.

Please, before you provide us with your personal data ("Data"), take a moment to read the following Privacy Notice (the "Notice"), in which we inform you, in accordance with the Federal Personal Data Held by Private Individuals Protection Act (the "Act") and its Regulation (the "Regulation"), about how and with what purpose we handle your personal information.

When providing us with your "Data", we understand you agree with the Terms on this Notice, the purpose of your Data handling, as well as the means and procedures we offer to exercise your rights of access, rectification, cancellation and objection in section VI of this Privacy Notice.

I. RESPONSIBILITY

The party responsible for data handling is the company known as COMERCIALIZADORA INTERNACIONAL DE COMPRESORES, S.A. DE C.V., with address at 2ª Cerrada de Calle 4 No. 27 Col. Granjas San Antonio, Deleg. Iztapalapa, being also able to contact us through e-mail: atencion.clientes@cic-sa.com.mx.

II. PURPOSE

All data obtained will be used for the following purposes:

Should we celebrate an agreement concerning any service provided by us, your "Data" will be used for fulfillment of obligations derived from said legal relation. In case no service agreement has been reached, all data provided by you will be locked and subsequently erased.

Any locked information may be retained as long as needed in order to comply with legal obligations such as fiscal or commercial, and subsequently erased.

III. OBTAINED DATA

We collect your personal data whenever requested: pricing, service requests, equipment, compressors, medical grade vacuum pump sales or any related to medical gases, as well as employment requests and contracts, or provisioning services to our company as well as when provided via other channels; with the purpose of providing services such as: Sale and maintenance of compressors and medical grade vacuum pumps, as well as medical gas projects. Data obtained via this medium may be, but not limited to:

Property data such as bank account numbers, and fiscal credit numbers.**

Fiscal and legal documents and certifications.**

Plans, blueprints and technical specifications.**

** Handling of such personal data requires, according to article 8 of the Federal Personal Data Held by Private Individuals Protection Act and 15 of its Regulation, written express consent of the owner, being sensitive and property data, and as such I accept the handling and storing of said data, according to the uses established in section II of this Privacy Notice. This Data is essential to our service provision and billing, when applicable, and shall be handled only for uses established in this Notice.

IV. DATA TRANSFER

Based on articles 36 and 37 of the Federal Personal Data Held by Private Individuals Protection Act, Data may be legally transferred for any purpose stated in this Privacy Notice to other third parties, subsidiaries or affiliates under the responsible company's common control, or to any parent company or party within the same group of the responsible company which operates under the same internal processes and policies, such as "Grupo CIC".

V. DATA PROTECTION

Protection of all personal data is guaranteed and it is protected by managerial, technical and physical security measures in order to avoid loss, tampering, destruction and unauthorized use, undue access or disclosure.

VI. ARCO RIGHTS

You may exercise your right of access, rectification, cancellation and objection and revoke your consent to handle your data (ARCO rights) via a request presented at: 2^a. Cerrada de Calle 4 No. 27 Col. Granjas San Antonio, Delg. Iztapalapa, Ciudad de México. C.P. 09070, as well as by the following electronic contact: atencion.clientes@cic-sa.com.mx.

Said request must contain as minimum: (a) Full name; (b) indicate if said request is done personally or via a representative, (c) address, (d) telephone number, (e) indicate acceptance of any notifications derived from such request to an e-mail address provided by you, (f) a clear and precise description of Personal Data over which you wish to exercise your ARCO rights; (h) any other element which facilitates your Data tracing (date in which said Data was provided, agreement ID number, company representative, involved departments) and (i) documents certifying identity and /or power of attorney.

Please remember that in accordance to Law, in order to complete your request, you shall previously certify your identity via your personal appearance with original and copy of identification and/or power of attorney.

Whenever a request is presented from clients outside of Mexico City, such requests may be presented via e-mail, along with digital copies of identification and/or power of attorney and wait for instructions to proceed forward. Likewise, the owner declares any Data provided is true, exact and complete, taking responsibility for any damage incurred by falsehood or identity usurpation. Any rectification request should be accompanied by documents certifying the request and data of requested modification. Such documents must be presented original and with copy for their confirmation.

The rest of the procedure will be processed according to the terms and steps established in the Act.

VII. DATA PRIVACY OF MINORS IS NOT ALLOWED

Should a minor declare being of legal age under fraudulent behavior, he/she will be subject to any responsibilities of any nature as applicable.

X. COMPLAINTS AND LAWSUITS
